Scholarship Information and Limitations

- Scholarships include a food voucher and reimbursement for transportation costs, including tolls and parking. CDPAANYS cannot guarantee 100% reimbursement for transportation.
- To qualify for a scholarship, you must be a CDPA consumer or DR with a CDPAANYS Provider Member fiscal intermediary, or be a consumer or DR that is a CDPAANYS individual member.
- Employees of fiscal intermediaries and/or CDPAANYS are not eligible for scholarships.
- You must be traveling to Albany by public transit or personal car. Limited funding means CDPAANYS unfortunately cannot subsidize ambulettes or buses organized by third parties.
- Travel cost reimbursements will be based on actual mileage (as determined by Google Maps) and actual expenses. No reimbursement will be given without proper documentation, including receipts, mileage reports, and EZ-Pass statements. All expense reimbursements will be distributed after they are incurred. CDPAANYS does not guarantee full reimbursement for expenses. We will do our best to inform you of estimated reimbursement prior to Lobby Day.
- CDPAANYS reserves the right to award scholarships in a manner that diversifies the recipient pool based on geography, FI provider, and/or other factors at our sole discretion.
